## ADDENDUM OF PROBABLE CAUSE

On or about July 3- 18th of 2017 the above named defendant committed the offense two counts (2) of Sexual Battery On Person Less Than 12 YOA By Person Over 18 in violation of F.S.S. 794.011 (2A) and one count (1) of Child Abuse-Without Causing Great Bodily Harm in violation of F.S.S. 827.03 (2C) when he took the victim's, (11 year old and seven year old who were raping them vaginally and anally on multiple times during their two week visit at Crestview, FL striking in the head during one of the incidents when she screamed out for the defendant to stop.

These offenses are evidenced by a recorded forensic interview on March 4, 2018 conducted by the United States Army CID in Fort Campbell, Kentucky. stated the defendant touched her inappropriately putting his "man parts" in her vagina on multiple occasions. stated on one occasion she had fallen asleep on the couch and woke up in the defendant's bed undressed with the defendant on top of her. stated she started "freaking out," was scared, tried to get away, and screamed. stated the defendant placed his hand over her mouth and held her down telling her "Don't scream." stated the defendant hit her on the head (couldn't remember if the defendant's hand was open or closed) and she "went back to sleep." stated when she woke back up, the defendant had placed his "man parts" in her butt and was rubbing her vagina and breast." stated when the defendant was done; she had "white stuff" on her butt, the defendant put her clothes back on and told her to go to the bathroom to clean off. stated she left the room crying, because her butt was hurting. stated there was another incident when she was in the defendant's bedroom, she tried to "escape," but he locked the door and took off all her clothes. stated these incidents happened "multiple times in his room." stated the defendant would tell her not to tell anyone after each time one of these incidents occurred.

These offenses are further evidenced by a recorded forensic interview on March 4, 2018 conducted by the United States Army CID in Fort Campbell, Kentucky. stated while visiting the defendant at his home in Florida, he touched her all over her body after taking her clothes off, and he put his "wee wee" in her "butt" on multiple occasions. stated the defendant touched her "impolitely" touching her butt and vagina. stated the defendant put her on his bed "making her do things she didn't want to do." stated the defendant would bend her over his bed and do things she didn't want him doing. stated the defendant would put things inside of her body, in the back of her body (butt). stated the defendant put his "male parts" inside of her on multiple occasions. stated she also remembered the defendant picking up off the couch where they slept during their visit taking her into his room and shutting the door. stated came out of the defendant's room crying, but she did not know what had happened to her.

These offenses are further evidenced by a recorded controlled call conducted by the United States Army CID in Fort Campbell, Kentucky with and 's mother identified as and the defendant. stated told her the defendant put his "dick in her ass," and when she tried to scream the defendant put his hand over 's mouth. stated to the defendant had to clean "white stuff" of her ass. stated told her the defendant rubbed her on "her ass." The defendant stated he never touched . The defendant stated he didn't remember doing anything like that, it was not something he would do, but "I don't think would lie about something like that," "That is super descriptive and

ADDENDUM OF PROBABLE CAUSE

I am sorry." The defendant states to . "you shouldn't ignore what the girls are telling you, nor should she believe they are lying." The defendant states he could have touched . 's butt, only when he was putting sunscreen on her in the bathroom." The defendant states he swears he doesn't remember doing it, but "it is pretty fucking terrible." states to the defendant she wants the truth about the incidents so she can get and the help they need. The defendant states "As far as I know that never happened, but that is descriptive." The defendant states "I don't want around me anymore; I don't think she should be around me anymore. The defendant states "What do you need me to do?" "Do you need me to talk to her and tell her I am sorry?" The defendant continues to state he does not remember doing anything like that to the girls. The defendant states "I can tell her I am sorry and maybe she can forgive me someday, maybe it is what she needs to hear." The defendant also states "I can definitely talk to too and tell her I am sorry.

These offenses did occur within the city limits of Crestview, Okaloosa County, FL.
